ORDINANCE NO. 3802

AN ORDINANCE AMENDING ORDINANCES NUMBERED 3794,3796,3797 AND 3799

AN ORDINANCE AMENDING THE ORDINANCES WHICH ESTABLISHED THE SALARIES OF THE FOLLOWING DEPARTMENTS WITHIN THE CITY OF NEW CASTLE:

- (1) HOURLY WORKERS;
- (2) ADMINISTRATIVE AND MANAGEMENT EMPLOYEES;
- (3) POLICE DEPARTMENT; AND
- (4) FIRE DEPARTMENT

WHEREAS, the Common Council established the salaries and benefits of:

- (1) Hourly Salaried Workers by passing Ordinance No. 3796
- (2) Administrative and Management salaries by passing Ordinance No. 3794
- (3) Police Department salaries by passing Ordinance No. 3799 and,
- (4) Fire Department salaries by passing Ordinance No. 3797

WHEREAS, it has been determined that said ordinances must be amended.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the following ordinances are amended as follows:

- 1. Ordinance No. 3794 is hereby amended as follows:
 - a. Police Department Merit Board Members \$50.00 per meeting to a maximum of \$350.00 annually.
- 2. Ordinance No. 3796 is hereby amended as follows:
 - a. City Building Building Custodians \$15.60 hourly
- 3. Ordinance No. 3797 is hereby amended as follows:
 - a. Longevity pay \$15.00 per pay
- 4. Ordinance No. 3799 is hereby amended as follows:
 - a. Extra Duty Pay No more than 2 extra duty pays per individual
 - b. Longevity pay \$15.00 per pay

All other provisions of Ordinances No. 3794,3796,3797 and 3799

not amended by this ordinance shall remain in full force and effect.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.
