ADMINISTRATIVE REPORTS:

- Attorney Copenhaver stated for the record he did not say as was printed in the Courier Times that they City could not give to the baby box program, but that the City could not give to a 501C3 charity but could put pay for the installation in one of our Fire Stations.
- Administrative Assistant Kennedy received a call from William Huber stating \$1,370.00 had been raised toward the purchase of the baby box. Mr. Huber will keep us informed on how the fundraising efforts move along.
- Superintendent Phipps stated that residents need to be aware that they will be flushing all 743 Fire Hydrants within the City this week now that the water tower at 22nd and "I" Avenue has now been filled again. Please refrain from doing laundry especially whites during this time.
- Superintendent Walker informed Council that there have been some issues in the past of
 people placing leaves and brush together. The machines used to take away the debris are
 different and placing leaves and brush in separate piles making it easier for pick up.

CITIZENS APPEARING BEFORE THE COUNCIL:

Mike McKown 417 S. 14th Street asked Council to look into making sure that people from the new Papa Johns which will be located in the lot next to him are not cutting through his lot. Vice-President Hancock stated. The owner of the new business had already presented before Council that they would be putting up privacy fencing with landscaping to avoid this.

Chris Cole Local #1722 voiced concern that Fire Union had not had negotiations and they were passing Fire Salary Ordinance on first reading. Mr. Cole thanked the Council and the Administration more than once on how well they have taken care of the Fire Department and assured Council that his statements were not made about money.
