

**ORDINANCE NO. 3470**

**AN ORDINANCE ESTABLISHING A ONE-WAY STREET**

WHEREAS, the Common Council of the City of New Castle has the duty to protect the public health, safety and welfare, and

WHEREAS, the Traffic Committee of the Common Council has reviewed traffic flow on Reddingdale Drive and has determined that it should be a one-way street.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle the Reddingdale Drive between Broad Street and Spring Street should be limited to one-way northbound traffic.

IT IS FURTHER ORDAINED that Chapter 74 Schedule VI(A) of the New Castle City Code shall be amended by adding the following:

STREET: Reddingdale Drive

LOCATION: From Broad Street to Spring Street

DIRECTION: Northerly

IT IS FURTHER ORDAINED by the Common Council that all provisions of Chapter 70 of the New Castle City Code shall apply and more particularly, the penalties set forth in Section 70.99 of said code. Further, if a violator admits to a citation issued pursuant to this chapter, the provisions of Section 70.22(a) 1, 2 and 3 shall apply.

IT IS FURTHER ORDAINED by this Council that the Street Department of this City shall post signs at the intersection of Reddingdale Drive and Broad Street and the intersection of Reddingdale Drive and Spring Street indicating that the street is a one-way street and traffic shall only be permitted to travel in a northerly direction on Reddingdale Drive between Broad Street and Spring Street.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed. Those provisions of the New Castle Code of Ordinances not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication and proper posting of one-way street signs on Reddingdale Drive.
