AN ORDINANCE REMOVING STOP SIGNS AT RAILROAD CROSSING

WHEREAS, it is the responsibility of the Common Council of the City of New Castle to provide for the public health, safety and welfare, and

WHEREAS, those police powers require this Council to consider changes with regard to traffic control devices when certain matters are brought to its attention, and

WHEREAS, from time to time this Council determines that certain traffic control devices are no longer needed due to those changes, and

WHEREAS, on Henry County Road 25 West, there are stop signs located on the North and South approach to a certain railroad crossing, and

WHEREAS, said railroad crossing is no longer in use and has not been used for a period of over twelve (12) months and thus the need for those stop signs no longer exist, and

WHEREAS, Henry County Road 25 West, due to annexation is now within the jurisdiction of this Council and within the city limits of the City of New Castle.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the stop signs located at the North and South approaches to a certain railroad spur which crosses Henry County Road 25 West immediately North of Indiana State Road 38 should be removed. If the Street Commissioner and Board of Public Works determine that an informational sign need be placed to warn citizens regarding a rise in the road or some other unsafe traffic condition, said Board of Works is authorized to erect such an informational sign. Further, should the industries which no longer use the railroad spur referred to herein find that their needs have changed and the spur becomes once again viable, this Council may in its discretion, reinstall said signs. A copy of this Ordinance shall be mailed to Allegany-Ludlum Steel Corporation and Outo Kumpu Steel Corporation so that they may be advised of the actions taken by the Council and keep the Council informed as to their intentions regarding this railroad spur.

REPEALER: All ordinances or parts of ordinances in conflict
herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
