

ORDINANCE NO. 3460

AN ORDINANCE MAKING A CERTAIN ALLEY ONE-WAY SOUTH.

WHEREAS, the Common Council has the duty of providing for the public health, safety and welfare of the residents of New Castle, Indiana, and

WHEREAS, it has been determined by the Traffic Committee of the Common Council that a dangerous situation exists on a certain alley located in New Castle, Indiana, and

WHEREAS, it has been determined that this situation can be corrected by making the alley one-way with traffic flowing in a southerly direction,

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of New Castle, that Chapter 74 Schedule IV(A) of the New Castle City Code shall be changed by designating as one-way the following alley:

STREET: Alley

LOCATION: 1st alley west of 18th Street (St. Rd. 103) running north and south bounded on the south by an alley and Bounded on the north by "R" Avenue

DIRECTION: Southerly

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL of the City of New Castle that the New Castle Street Department shall immediately upon passage of this ordinance install the appropriate signage to carry out the intent of this ordinance and properly inform the motoring public. Said signage shall conform with the provisions of the Indiana Manual on Uniform Traffic Control Devices.

Upon passage of this ordinance, the above alley referred to in Chapter 74 Schedule IV(A) of the New Castle City Code shall deemed to be one-way alley as that term is defined in I.C. 9-21-8-9. Said one-way alley is created pursuant to the authority granted this Common Council by I.C. 9-21-1-3(4).

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL of the City of New Castle that in addition to the penalties imposed for violation of posted one-way alley designation by the applicable provisions of the Indiana Code, violators of this ordinance may also be subject to penalty and fine pursuant to Section 70.99 of the New Castle City Code where in the discretion of the arresting officer the application of said penalty is appropriate.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed. Those provisions of the New Castle Code of Ordinances not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by

operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
