May 2, 2022 at 10:00 a.m.

The meeting was called to order by Mayor York

Attendance: Present: Mayor York, Attorney Harvey
Absent: Director Barker

- Before the Start of the meeting Firefighter Zachary Shank took the Oath of Office as a new firefighter for the City of New Castle.

CITIZENS APPEARING:

- Katherine Ivey with 1822 Vintage Boutique asked for 14th Street between Broad and Fleming be shut down from 3pm – 8pm to bring in an outreach group from Muncie for a pride event. Mayor York moved to approved. Attorney Harvey seconded. Motion carried 3-0.
- Douglas Dudley 2100 Spring Street asked that the curb be painted back yellow as it was before on the corner of 21st and Spring. People are parking there and are making it hazardous for that area.



- Building Inspector Melton received a request for a handicap sign at 808 S. 11th. Chief Schofield and Superintendent Walker will take a look at where they want it located.


